Doodles-n-Company reserves the right to select a newborn puppy, or puppies, from any newborn litter to improve our breeding program.

Doodles-n-Company hereby guarantees that said dog has been examined by a licensed veterinarian and is believed to be in good health at the time of sale. The puppy has received appropriate vaccinations, a proper diet, nurturing care, and the necessary worming regimen for the pup's age.

Doodles-n-Company will continue to be available for any questions during the entire lifetime of this pet. Your puppy will be examined by a veterinarian prior to coming home to you. Doodles-n-Company will administer the puppy's first vaccinations DA2PP (distemper, Adenovirus Types 1 and 2, Parainfluenza, Parvovirus). The puppies will also complete a worming regimen to age.

The Purchaser has Four (4) days from the time of receipt to have this puppy examined by a licensed veterinarian. Proof of examination must be provided to Doodles-n-Company. This guarantee will be terminated immediately if the puppy/dog is not examined within the allotted time. If a life threatening illness or defect is found by the veterinarian within the first 7 days, the purchaser will have 24 hours to notify Doodles-n-Company and send all veterinary documentation supporting this diagnosis to Doodles-n-Company. In this case, a full refund of the purchase price of the puppy will be given if the puppy is returned within 7 days of purchase. Travel expenses are the responsibility of the purchaser.

Purchaser's Responsibility

1. The buyer agrees that their puppy will be housed indoors
2. The buyer agrees to feed their puppy only a premium quality food.
3. The buyer agrees to keep their puppy at a healthy weight.
4. The buyer agrees to make, and keep, annual veterinary appointments for this dog and to keep all immunizations current.
5. The Buyer is encouraged to provide basic obedience training with their puppy within the first year of owning their dog.
6. The Buyer agrees to postpone strenuous, repetitive exercise until after their puppy has reached one year of age.

We guarantee that our puppies will not be effected by DM, PRA, VWD, OST, or Gm2. If, by the age of 5 years, said dog is found to have one of the above genetic diseases clinically impacting it's quality of life, Doodles-n-Company will refund buyer 25% of original sale price. This must be stated and certified by a qualified veterinarian and paid for at buyer's expense. The seller has the right to require a second opinion from a veterinarian of the seller's choice, at the seller's expense.

We warranty hip dysplasia for 2 years from the date of birth. This warranty will be terminated should the said dog be allowed to become overweight or should developing joints become overstressed at any point during the warranty period. Should said dog be found to have Hip Dysplasia within the first two years, the purchaser must provide Doodles-n-Company with proof in the form of documentation from OFA or Penn HIP. This warranty only covers life altering conditions that require hip replacement. Purchaser must provide Doodles-n-Company with x-rays of hips and copies of complete veterinary history showing that the puppy/dog has been properly vaccinated from the date of this contract (four complete rounds of vaccinations), yearly vaccinations, and monthly heartworm medication. The x-rays will then be evaluated by our veterinarian. The defect/hip rating must be sufficient enough that it would require a hip replacement or would be debilitating to the dog. This health guarantee does not warrant hip issues that are caused by being overweight or as the result of an injury. Doodles-n-Company

will not refund shipping or transportation costs. These costs will be the responsibility of the purchaser.

Doodles-n-Company must be notified within 24 hours of a veterinary exam, providing us written & signed confirmation from your licensed veterinarian, explaining any life threatening genetic defect found.

This warranty does not include Dental Work, Luxating Patella, Viral Illnesses, Infections, Improper Bites, Hernias, Hypoglycemia, Heartworm, Giardia, or Coccidiosis. It also does not include any illness due to the ingestion of foreign objects, food, chemicals, or any physical injury. If said dog is euthanized, or in any way disposed, of without a second opinion from the seller's preferred veterinarian, the buyer waives all rights to a replacement puppy or to any financial payment as compensation. Every puppy is an individual and the breeder cannot be held responsible should conditions, genetic or otherwise, develop later in life. This guarantee does not cover mistreatment of said puppy, injury, accidents, poisoning, etc., overweight dogs, underweight dogs and dogs that have been used in agility, running, jumping or over exercised during their growth period of 24 months, during the period of guarantee. It does not cover trauma related or environmental factors that have affected the dog adversely. This guarantee applies only to the original purchaser of this dog.

The Purchaser must contact Doodles-n-Company within 24 hours of any life threatening diagnosis. The purchaser must supply Doodles-n-Company a veterinarian's report indicating any life threatening genetic defects within seven days of making the first notification to the seller. The purchaser's veterinarian must forward a copy of all available reports to the seller for review. The seller will review the reports and advise if a second opinion is required. If so, the seller will nominate a second veterinarian to whom the dog should be taken for further examination. The seller will make available all results from the second opinion to the purchaser. If said dog is diagnosed to have a hereditary defect clinically impacting the dogs' quality of life, by both nominated veterinarian's, the seller may enact one of the following options: - NOT BOTH -

1. The seller may replace with a puppy/dog of equal value upon meeting the above requirements. It is understood that there may not be a replacement dog available at the time of requested replacement. Doodles-n-Company is therefore allotted twenty-four months to act upon this replacement guarantee.

OR

2. The seller will refund 25% of the purchase price. (Not including shipping cost, vet or travel expenses.)

Doodles-n-Company cannot guarantee color, coat type, size, or temperament. These things can only be estimated.

Doodles-n-Company does not assume any responsibility for puppy expenses once said puppy leaves our premises. All costs (i.e. veterinary, medications, grooming, transportation, training, etc.) are the responsibility of the purchaser. Doodles-n-Company will bare no responsibility for any injury or illness to your pet that could have been contracted after the date of purchase.

Rehoming:

Purchaser agrees that if at any time the Purchaser cannot keep said dog, they will, first notify Doodles-n-Company. Purchaser will, second, make all attempts to re-home said dog to a safe & nurturing environment. Said dog must not be destroyed or relinquished to a pound or shelter.

Doodles-n-Company will take any Doodles-n-Company puppy/dog back into our care, if you are unable to properly care for him/her or to find a proper home for him/her. No refund will be given in this instance and the purchaser is responsible for all transportation costs. You must return your puppy/dog with all documentation and veterinary records as well.

Spay/Neuter Agreement:

Doodles-n-Company requires your puppy to be spayed/neutered by the age of one year. The Purchaser is required to send Doodles-n-Company, by way of USPS or email, a copy of the spay/ neuter documentation, signed by the veterinarian clearly stating that the procedure was performed and when it was performed. It is not the veterinarian's responsibility to send this documentation. It is the responsibility of the purchaser.

By signing below, the purchaser agrees to have this puppy spayed/neutered by 12 months of age. In the event that Doodles-n-Company does not receive proof of spay/neuter within [12 months], or the puppy turning 1 year of age, by a licensed veterinarian, this entire health warranty will be void. If the surgery is not done within one year from the date of birth, it will be considered a breach of contract and the buyer will be liable for \$125,000 for breeding rights and would void any warranty/health guarantee as stated in this contract. If a pregnancy occurs prior to the 12 month period before the spay/neuter deadline, whether purposely or accidentally, the PURCHASER agrees to pay an additional cost of \$20,000.00. The PURCHASER also agrees that failure to comply with this agreement will void the Health Guarantee. In the case that any legal action would need to be taken regarding this puppy, it will be taken up in the courts of St. Clair County, Michigan.

Permanent ownership of this dog is contingent upon purchaser compliance with this Addendum. Doodles-n-Company must receive signed proof from your veterinarian, of the spay/neuter of your pet. In the event that surgery is not done, Doodles-n-Company must be provided with a statement from your veterinarian that said dog is not yet in physical or emotional condition for surgery. Based upon the veterinarian's evaluation of said dog, the PURCHASER will contact the veterinarian and establish the earliest date that the procedure can be performed. The PURCHASER will notify the BREEDER of this amendment in writing, along with the veterinarian's signed

statement of their findings, at which time all other conditions of this agreement will apply and be enforced.

This health guarantee/contract is not transferable and only applies to the original purchaser of this puppy. Doodles-n-Company will not release a puppy from our possession until we have this signed contract in hand.

Definition: The warranty set forth in this contract is the sole warranty and is given in lieu of any and all other warranties, expressed or implied. The buyer's sole remedy is under the warranty provision of this contract and the Seller disclaims and will not be liable for any other damages including consequential damages, property damage, emotional distress, loss of use, business interruption, or veterinary fees unless specifically set forth in this warranty provision. This contract sets forth the entire agreement between the seller and buyer and any inconsistent oral terms have no effect on this contract. If there is any dispute or litigation between the seller and buyer, the prevailing party will be entitled to reasonable attorney's fees and costs. I, the purchaser of the dog described on this document do hereby declare that I have read and do fully understand and agree with the terms of this contract. I understand by signing this agreement it becomes a legal binding contract.
